This role will be based at Norfolk Island.

Position Classification: Level 4.1 \$31.88 per hour plus 25% casual loading

Roster Conditions: Due to the nature of airport operations, this role requires a high degree of flexibility, including availability for **weekend work**, **short-notice callouts**, and alignment with flight schedules. **Benefits:** 12% superannuation + entitlements in accordance with NIRC's Certified Enterprise Agreement

Key Accountabilities: (Copy of Full Duties- Position Description can be obtained from the link)

- Deliver safe, efficient, and compliant flight operations and airside services in accordance with Norfolk Island Airport's operational standards and regulatory obligations.
- Maintain accurate operational records, logs, and invoice data for all relevant activities.
- Communicate effectively with aircraft, stakeholders, and emergency services to support situational awareness and operational coordination.
- Conduct inspections, manage hazards, and respond to airfield issues to ensure continuous aerodrome safety.
- Facilitate access control processes, including ASIC, ADP/AVP, and visitor pass issuance.
- Adhere to all airport policies, including safety, security, and drug and alcohol compliance.
- Participate in rostered and on-call duties, including weekends and short-notice operational coverage.
- Support the Airport Operations Manager and contribute to operational continuity, including acting in higher duties when required.

All required training and certifications will be provided to the right applicant who will need to be able to attain the following mandatory qualifications. One should demonstrate a genuine **commitment to the role** and a willingness to remain in the position for a reasonable period to ensure a return on investment in training and onboarding.
