1. INTRODUCTION

This Norfolk Island Regional Council Code of Meeting Practice is prescribed under section 360 of the *Local Government Act 1993 (NSW) (NI)* (the Act) and the *Local Government (General) Regulation 2005 (NSW)(NI)* (the Regulation).

The code applies to all meetings of council and committees of council of which all the members are councillors (committees of council). Council committees whose members include persons other than councillors may adopt their own rules for meetings unless council determines otherwise.

Councils must adopt a code of meeting practice that incorporates the mandatory provisions of the [Model Code of Meeting Practice for Local Councils in NSW](#).

A council's adopted code of meeting practice may also incorporate the non-mandatory provisions of the Model Meeting Code and other supplementary provisions. However, a code of meeting practice adopted by a council must not contain provisions that are inconsistent with the mandatory provisions of this Model Meeting Code.

A council and a committee of council of which all the members are councillors must conduct its meetings in accordance with this code of meeting practice.

2. MEETING PRINCIPLES

2.1 Council and committee meetings should be:

<i>Transparent:</i>	Decisions are made in a way that is open and accountable.
<i>Informed:</i>	Decisions are made based on relevant, quality information.
<i>Inclusive:</i>	Decisions respect the diverse needs and interests of the local community.
<i>Principled:</i>	Decisions are informed by the principles prescribed under Chapter 3 of the Act.
<i>Trusted:</i>	The community has confidence that councillors and staff act ethically and make decisions in the interests of the whole community.
<i>Respectful:</i>	Councillors, staff and meeting attendees treat each other with respect.
<i>Effective:</i>	Meetings are well organised, effectively run and skilfully chaired.
<i>Orderly:</i>	Councillors, staff and meeting attendees behave in a way that contributes to the orderly conduct of the meeting.

3. BEFORE THE MEETING

Timing of ordinary council meetings

3.1 Council shall, by resolution, set the frequency, time, date and place of its ordinary meetings.

Note: Under section 365 of the Act, councils are required to meet at least ten (10) times each year, each time in a different month unless the Minister for Local Government has approved a reduction in the number of times that a council is required to meet each year under section 365A. (The Minister for Local Government is the Minister for Regional Development, Local Government and Territories).

Extraordinary meetings

3.2 If the mayor receives a request in writing, signed by at least two (2) councillors, the mayor must call an extraordinary meeting of council to be held as soon as practicable, but in any event, no more than fourteen (14) days after receipt of the request. The mayor can be one of the two councillors requesting the meeting.

Clause 3.2 reflects section 366 of the Act

3.3 The mayor may call an extraordinary meeting without the need to obtain the signature of two councillors.

Notice to the public of council meetings

- 3.4 Council must give notice to the public of the time, date and place of each of its meetings, including extraordinary meetings and of each meeting of committees of council.

Clause 3.4 reflects section 9(1) of the Act.

- 3.5 For the purposes of clause 3.4, notice of a meeting of council and of a committee of council is to be published before the meeting takes place. The notice must be published on council's website, and in such other manner that council is satisfied is likely to bring notice of the meeting to the attention of as many people as possible.

- 3.6 For the purposes of clause 3.4, notice of more than one (1) meeting may be given in the same notice.

Notice to councillors of ordinary council meetings

- 3.7 The general manager must send to each councillor, at least three (3) days before each meeting of council, a notice specifying the time, date and place at which the meeting is to be held, and the business proposed to be considered at the meeting.

Clause 3.7 reflects section 367(1) of the Act.

- 3.8 The notice and the agenda for, and the business papers relating to, the meeting may be given to councillors in electronic form, but only if all councillors have facilities to access the notice, agenda and business papers in that form.

Clause 3.8 reflects section 367(3) of the Act.

Notice to councillors of extraordinary meetings

- 3.9 Notice of less than three (3) days may be given to councillors of an extraordinary meeting of council in cases of emergency.

Clause 3.9 reflects section 367(2) of the Act.

Giving notice of business to be considered at council meetings

- 3.10 A councillor may give notice of any business they wish to be considered by council at its next ordinary meeting by way of a notice of motion. To be included on the agenda of the meeting, the notice of motion must be in writing and must be submitted by Monday 4:30pm the week preceding council meeting, six (6) business days before the meeting is to be held.

- 3.11 A councillor may, in writing to the general manager, request the withdrawal of a notice of motion submitted by them prior to its inclusion in the agenda and business paper for the meeting at which it is to be considered.

Questions with notice

- 3.12 A councillor may, by way of a notice submitted under clause 3.10, ask a question for response by the general manager about the performance or operations of council.

- 3.13 A councillor is not permitted to ask a question with notice under clause 3.10 that comprises a complaint against the general manager or a member of staff of council, or a question that implies wrongdoing by the general manager or a member of staff of council
- 3.14 **A councillor is not permitted to ask a question with notice under clause 3.12 that would constitute an act of disorder.**
- 3.15 The general manager or their nominee may respond to a question with notice submitted under clause 3.12 by way of a report included in the business papers for the relevant meeting of council or ~~orally~~ verbally at the meeting.

Agenda and business papers for ordinary meetings

- 3.16 The general manager must cause the agenda for a meeting of council or a committee of council to be prepared as soon as practicable before the meeting.
- 3.17 The general manager must ensure that the agenda for an ordinary meeting of council states:
- (a) all matters to be dealt with arising out of the proceedings of previous meetings of council, and
 - (b) if the mayor is the chairperson – any matter or topic that the chairperson proposes, at the time when the agenda is prepared, to put to the meeting, and
 - (c) all matters, including matters that are the subject of staff reports and reports of committees, to be considered at the meeting, and
 - (d) any business of which due notice has been given under clause 3.9.
- 3.18 Nothing in clause 3.17 limits the powers of the mayor to put a mayoral minute to a meeting under clause 9.6.
- 3.19 The general manager must not include in the agenda for a meeting of council any business of which due notice has been given if, in the opinion of the general manager, the business is, or the implementation of the business would be, unlawful. The general manager must report, without giving details of the item of business, any such exclusion to the next meeting of council.
- 3.20 Where the agenda includes the receipt of information or discussion of other matters that, in the opinion of the general manager, is likely to take place when the meeting is closed to the public, the general manager must ensure that the agenda of the meeting:
- (a) identifies the relevant item of business and indicates that it is of such a nature (without disclosing details of the information to be considered when the meeting is closed to the public), and
 - (b) states the grounds under section 10A(2) of the Act relevant to the item of business.
- 3.21 The general manager must ensure that the details of any item of business which, in the opinion of the general manager, is likely to be considered when the meeting is closed to the public, are included in a business paper provided to councillors for the meeting concerned. Such details must not be included in the business papers made

available to the public and must not be disclosed by a councillor or by any other person to another person who is not authorised to have that information.

Statement of ethical obligations

- 3.22 Business papers for all ordinary and extraordinary meetings of council and committees of council must contain a statement reminding councillors of their oath or affirmation of office made under section 233A of the Act and their obligations under the council's code of conduct to disclose and appropriately manage conflicts of interest.

Availability of the agenda and business papers to the public

- 3.23 The Norfolk Island Regional Council's Ordinary Meeting of Council business papers **will be published on the council's website and provided to the members** of the community in digital format only. A USB thumb drive containing a PDF copy of the business paper will be available for collection, free of charge, from the council chambers or the visitor information centre on the Monday prior to the scheduled meeting as well as at the meeting venue on the day.

- 3.24 Clause 3.23 does not apply to the business papers for items of business that the general manager has identified under clause 3.21 as being likely to be considered when the meeting is closed to the public.

Clause 3.24 reflects section 9(2A)(b) of the Act.

- 3.25 For the purposes of clause 3.23, copies of agendas and business papers must be published on council's website and made available to the public at a time that is as close as possible to the time they are available to councillors.

Clause 3.25 reflects section 9(3) of the Act.

- 3.26 A copy of an agenda, or of an associated business paper made available under clause 3.21, may in addition be given or made available in electronic form.

Clause 3.26 reflects section 9(5) of the Act.

Agenda and business papers for extraordinary meetings

- 3.27 The general manager must ensure that the agenda for an extraordinary meeting of council deals only with the matters stated in the notice of the meeting.

- 3.28 Nothing in clause 3.27 limits the powers of the mayor to put a mayoral minute to an extraordinary meeting without notice under clause 9.6.**

- 3.29 Despite clause 3.27, business may be considered at an extraordinary meeting of council, even though due notice of the business has not been given, if:

- (a) a motion is passed to have the business considered at the meeting, and
- (b) the business to be considered is ruled by the chairperson to be of great urgency on the grounds that it requires a decision by council before the next scheduled ordinary meeting of council.

- 3.30 A motion moved under clause 3.29 can be moved without notice but only after the business notified in the agenda for the extraordinary meeting has been dealt with.

- 3.31 Despite any other provision of this code, only the mover of a motion moved under clause 3.29, and the chairperson, if they are not the mover of the motion, can speak to the motion before it is put .**
- 3.32 If all councillors are not present at the extraordinary meeting, the council may only deal with business at the meeting that councillors have not been given due notice of, where a resolution is adopted in accordance with clause 3.29 and the chairperson also rules that the business is urgent and requires a decision by the council before the next scheduled ordinary meeting.**
- 3.33 A motion of dissent cannot be moved against a ruling of the chairperson under clause 3.33 on whether a matter is of great urgency.

Pre-meeting briefing sessions— TO BE DELETED

Note: The prohibition on the holding of briefing sessions under clause 3.31 reflects the intent of Chapter 4, Part 1 of the Act which requires business of the council to be conducted openly and transparently at a formal meeting of which due notice has been given and to which the public has access. Pre-meeting briefing sessions are inconsistent with the principles of transparency, accountability and public participation and have the potential to undermine confidence in the proper and lawful decision-making processes of the council.

- ~~3.29 Prior to each ordinary meeting of council, the general manager will arrange a pre-meeting briefing session commencing at 5pm on the Tuesday, the day before the Council meeting on the Wednesday, to brief councillors on business to be considered at the meeting. Pre-meeting briefing sessions may also be held for extraordinary meetings of council and meetings of committees of council.~~
- ~~3.30 Pre-meeting briefing sessions are to be held in the absence of the public.~~
- ~~3.31 Pre-meeting briefing sessions may be held by audio-visual link.~~
- ~~3.32 The general manager or a member of staff nominated by the general manager is to preside at pre-meeting briefing sessions.~~
- ~~3.33 Councillors must not use pre-meeting briefing sessions to debate or make preliminary decisions on items of business they are being briefed on, and any debate and decisionmaking must be left to the formal council or committee meeting at which the item of business is to be considered.~~
- ~~3.34 Councillors (including the mayor) must declare and manage any conflicts of interest they may have in relation to any item of business that is the subject of a briefing at a pre-meeting briefing session, in the same way that they are required to do so at a council or committee meeting. Council is to maintain a written record of all conflict of interest declarations made at pre-meeting briefing sessions and how the conflict of interest was managed by the councillor who made the declaration.~~

4. PUBLIC ACCESS

- 4.1 Public Access will be conducted on the day of the council meeting commencing at 2pm as part of the council meeting order of business.**

- (a) A time limit of five (5) minutes per speaker or such longer period as resolved by the mayor.
- (b) The subject matter only is to be discussed, and the matter should refer to items on the business agenda.
- (c) Debate will not be permitted.
- (d) A speaker cannot speak on the same subject at more than one council meeting without the consent of the mayor and the general manager.
- (e) An application to address council must be made in writing to the mayor by 4.00pm on the Monday prior to the council meeting on the Wednesday and set out details of the matter to be raised. The general manager and the mayor will determine whether or not the applicant will be entitled to speak at the meeting.
- (f) No more than six (6) addresses for a maximum period of five (5) minutes duration are to be listed for any one meeting.
- (g) The speaker must address council courteously and must only speak on the topic of their question as submitted.
- (h) The speaker must refrain from making allegations about the mayor, council staff or other members of the community.
- (i) The general manager may invite consultants and guest speakers to address council on matters on the business agenda for periods of up to 30 minutes in duration. A standard presentation would be from council's external auditor to speak on the annual financial reports.
- (j) The mayor may at his or her discretion invite a guest speaker to speak on a subject relevant to council business.

4.2 Petitions

- (a) All petitions are to be addressed to the general manager.
- (b) The Prayer (purpose) of the petition is to be included on each page.
- (c) Council will acknowledge receipt of the petition only to the head petitioner.
- (d) When a petition is presented in a meeting of council, the appropriate action is that the petition be noted and acknowledged.
- (e) Petitions accepted by a meeting of council will be recorded in the minutes.

5. COMING TOGETHER

Attendance by councillors at meetings

- 5.1 All councillors must make reasonable efforts to attend meetings of council and of committees of council of which they are members.

Note: A councillor may not attend a meeting as a councillor (other than the first meeting of council after the councillor is elected or a meeting at which the councillor

takes an oath or makes an affirmation of office) until they have taken an oath or made an affirmation of office in the form prescribed under section 233A of the Act.

- 5.2 A councillor cannot participate in a meeting of council or of a committee of council unless personally present at the meeting, unless permitted to attend the meeting by audio-visual link under this code.
- 5.3 Attendance at all council meetings is permitted remotely to cater for any potential changes to travel restrictions to and from Norfolk Island.
- 5.4 **Where a councillor is unable to attend one or more meetings of the council or committees of the council, the councillor should submit an apology for the meetings they are unable to attend, state the reasons for their absence from the meetings and request that the council grant them a leave of absence from the relevant meetings.**
- 5.5 ~~A councillor's request for leave of absence from council meetings should, if practicable, identify (by date) the meetings from which the councillor intends to be absent and the grounds upon which the leave of absence is being sought.~~
- 5.6 Council must act reasonably when considering whether to grant a councillor's request for a leave of absence.
- 5.7 A councillor's civic office will become vacant if the councillor is absent from three (3) consecutive ordinary meetings of council without prior leave of council, or leave granted by council at any of the meetings concerned, unless the holder is absent because they have been suspended from office under the Act, or because council has been suspended under the Act, or as a consequence of a compliance order under section 438HA.

Clause 5.7 reflects section 234(1)(d) of the Act.

- 5.8 A councillor who intends to attend a meeting of council despite having been granted a leave of absence should, if practicable, give the general manager at least two (2) days' notice of their intention to attend.
- 5.9 Norfolk Island Regional Council Ordinary Council meetings will be live broadcast on Radio Norfolk radio station.

The quorum for a meeting

- 5.10 The quorum for a meeting of council is a majority of the councillors of council who hold office at that time and are not suspended from office.

Clause 5.10 reflects section 368(1) of the Act.

- 5.11 Clause 5.10 does not apply if the quorum is required to be determined in accordance with directions of the Minister in a performance improvement order issued in respect of council.

Clause 5.11 reflects section 368(2) of the Act.

- 5.12 A meeting of council must be adjourned if a quorum is not present:

- (a) at the commencement of the meeting where the number of apologies received for the meeting indicates that there will not be a quorum for the meeting, or
- (b) within half an hour after the time designated for the holding of the meeting, or

- (c) at any time during the meeting.

5.13 In either case, the meeting must be adjourned to a time, date, and place fixed:

- (a) by the chairperson, or
- (b) in the chairperson's absence, by the majority of the councillors present, or
- (c) failing that, by the general manager.

5.14 The general manager must record in council's minutes the circumstances relating to the absence of a quorum (including the reasons for the absence of a quorum) at or arising during a meeting of council, together with the names of the councillors present.

5.15 Where, prior to the commencement of a meeting, it becomes apparent that a quorum may not be present at the meeting, or that the health, safety and welfare of councillors, council staff and members of the public may be put at risk by attending the meeting because of a natural disaster or a public health emergency, the mayor may, in consultation with the general manager and, as far as is practicable, with each councillor, cancel the meeting. Where a meeting is cancelled, notice of the cancellation must be published on council's website and in such other manner that council is satisfied is likely to bring notice of the cancellation to the attention of as many people as possible.

5.16 Where a meeting is cancelled under clause 5.13, the business to be considered at the meeting may instead be considered, where practicable, at the next ordinary meeting of council or at an extraordinary meeting called under clause 3.2.

Meetings held by audio-visual link

5.17 A meeting of council or a committee of council may be held by audio-visual link where the mayor determines that the meeting should be held by audio-visual link because of a natural disaster or a public health emergency. The mayor may only make a determination under this clause where they are satisfied that attendance at the meeting may put the health and safety of councillors and staff at risk. The mayor must make a determination under this clause in consultation with the general manager and, as far as is practicable, with each councillor.

5.18 Where the mayor determines under clause 5.17 that a meeting is to be held by audio-visual link, the general manager must:

- (a) give written notice to all councillors that the meeting is to be held by audio-visual link, and
- (b) take all reasonable steps to ensure that all councillors can participate in the meeting by audio-visual link, and
- (c) cause a notice to be published on council's website and in such other manner the general manager is satisfied will bring it to the attention of as many people as possible, advising that the meeting is to be held by audio-visual link and providing information about where members of the public may view the meeting.

5.19 This code applies to a meeting held by audio-visual link under clause 5.17 in the same way it would if the meeting was held in person.

Note: Where a council holds a meeting by audio-visual link under clause 5.17, it is still required under section 10 of the Act to provide a physical venue for members of the public to attend in person and observe the meeting.

Attendance by councillors at meetings by audio-visual link

- 5.20 Councillors may attend and participate in meetings of council and committees of council by audio-visual link with the approval of council or the relevant committee.
- 5.21 A request by a councillor for approval to attend a meeting by audio-visual link must be made in writing to the general manager prior to the meeting in question and must provide reasons why the councillor will be prevented from attending the meeting in person.
- 5.22 Councillors may request approval to attend more than one meeting by audio-visual link. Where a councillor requests approval to attend more than one meeting by audio-visual link, the request must specify the meetings the request relates to in addition to the information required under clause 5.21.
- 5.23 Clause 5.20 does not apply to meetings at which a mayoral election is to be held.**
- 5.24 Council must comply with the Health Privacy Principles prescribed under the NSW *Health Records and Information Privacy Act 2002* when collecting, holding, using and disclosing health information in connection with a request by a councillor to attend a meeting by audiovisual link.
- 5.25 A councillor who has requested approval to attend a meeting of council or a committee of council by audio-visual link may participate in the meeting by audio-visual link until council or committee determines whether to approve their request and is to be taken as present at the meeting. The councillor may participate in a decision in relation to their request to attend the meeting by audio-visual link.
- 5.26 A decision whether to approve a request by a councillor to attend a meeting of council or a committee of council by audio-visual link must be made by a resolution of council or the committee concerned. The resolution must state:
- (a) the meetings the resolution applies to, and
 - (b) the reason why the councillor is being permitted to attend the meetings by audiovisual link where it is on grounds other than illness, disability, or caring responsibilities.
- 5.27 If council or committee refuses a councillor's request to attend a meeting by audio-visual link, their link to the meeting is to be terminated.
- 5.28 A decision whether to approve a councillor's request to attend a meeting by audio-visual link is at council's or the relevant committee's discretion. Council and committees of council must act reasonably when considering requests by councillors to attend meetings by audio-visual link. However, council and committees of council are under no obligation to approve a councillor's request to attend a meeting by audio-visual link where the technical capacity does not exist to allow the councillor to attend the meeting by these means.

- 5.29 Council and committees of council may refuse a councillor's request to attend a meeting by audio-visual link where council or committee is satisfied that the councillor has failed to appropriately declare and manage conflicts of interest, observe confidentiality or to comply with this code on one or more previous occasions they have attended a meeting of council or a committee of council by audio-visual link.
- 5.30 This code applies to a councillor attending a meeting by audio-visual link in the same way it would if the councillor was attending the meeting in person. Where a councillor is permitted to attend a meeting by audio-visual link under this code, they are to be taken as attending the meeting in person for the purposes of the code and will have the same voting rights as if they were attending the meeting in person.
- 5.31 A councillor must give their full attention to the business and proceedings of the meeting when attending a meeting by audio-visual link. The councillor's camera must be on at all times during the meeting except as may be otherwise provided for under this code.
- 5.32 A councillor must be appropriately dressed when attending a meeting by audio-visual link and must ensure that no items are within sight of the meeting that are inconsistent with the maintenance of order at the meeting or that are likely to bring council or the committee into disrepute.

Entitlement of the public to attend council meetings

- 5.33 Everyone is entitled to attend a meeting of council and committees of Council. Council must ensure that all meetings of council and Committees of council are open to the public. Appropriate arrangements will be made for each meeting to provide for the security and

well-being of councillors and staff, this may include separation from public areas of the council chambers / meeting rooms as deemed appropriate.

Clause 5.33 reflects section 10(1) of the Act.

- 5.34 Clause 5.33 does not apply to parts of meetings that have been closed to the public under section 10A of the Act.

- 5.35 A person (whether a councillor or another person) is not entitled to be present at a meeting of council or a committee of council if expelled from the meeting:

- (a) by a resolution of the meeting, or
- (b) by the person presiding at the meeting if council has, by resolution, authorised the person presiding to exercise the power of expulsion.

Clause 5.35 reflects section 10(2) of the Act.

Clause 13.9 confers a standing authorisation on all chairpersons of meetings of council and committees of council to expel persons from meetings. Clause 13.9 authorises chairpersons to expel any person, including a councillor, from a council or committee meeting.

Webcasting of meetings / Livestreaming of meeting

- 5.36 Each meeting of the council or a committee of the council is to be recorded by means of an audio or audio-visual device.
- 5.37 At the start of each meeting of the council, the chairperson must inform the persons attending the meeting that:
- (a) the meeting is being recorded and made publicly available on the council's website, and
 - (b) persons attending the meeting should refrain from making any defamatory statements.
- 5.38 The recording of a meeting is to be made publicly available on the council's website for at least 12 months after the meeting. Recordings are to be retained after being removed from council's website in accordance with relevant record keeping legislation applied to Norfolk Island from time to time.
- 5.39 Clauses 5.36 and 5.38 do not apply to any part of a meeting that has been closed to the public in accordance with section 10A of the Act.

Attendance of the general manager and other staff at meetings

- 5.40 The general manager is entitled to attend, but not to vote at, a meeting of council or a meeting of a committee of council of which all of the members are councillors.

Clause 5.40 reflects section 376(1) of the Act.

- 5.41 The general manager is entitled to attend a meeting of any other committee of council and may, if a member of the committee, exercise a vote.

Clause 5.41 reflects section 376(2) of the Act.

- 5.42 The general manager may be excluded from a meeting of council or a committee while council or committee deals with a matter relating to the standard of performance of the general manager or the terms of employment of the general manager.

Clause 5.42 reflects section 376(3) of the Act.

- 5.43 The attendance of other council staff at a meeting, (other than as members of the public) shall be with the approval of the general manager.

- 5.44 The general manager and other council staff may attend meetings of the council and committees of the council by audio-visual-link. Attendance by council staff at meetings by audio-visual link (other than as members of the public) shall be with the approval of the general manager.

6. THE CHAIRPERSON

The chairperson at meetings

- 6.1 The mayor, or at the request of or in the absence of the mayor, the deputy mayor (if any) presides at meetings of council.

Clause 6.1 reflects section 369(1) of the Act.

- 6.2 If the mayor and the deputy mayor (if any) are absent, a councillor elected to chair the meeting by the councillors present presides at a meeting of council.

Clause 6.2 reflects section 369(2) of the Act.

Election of the chairperson in the absence of the mayor and deputy mayor

- 6.3 If no chairperson is present at a meeting of council at the time designated for the holding of the meeting, the first business of the meeting must be the election of a chairperson to preside at the meeting.
- 6.4 The election of a chairperson must be conducted:
- (a) by the general manager or, in their absence, an employee of council designated by the general manager to conduct the election, or
 - (b) by the person who called the meeting or a person acting on their behalf if neither the general manager nor a designated employee is present at the meeting, or if there is no general manager or designated employee.
- 6.5 If, at an election of a chairperson, two (2) or more candidates receive the same number of votes and no other candidate receives a greater number of votes, the chairperson is to be the candidate whose name is chosen by lot.
- 6.6 For the purposes of clause 6.5, the person conducting the election must:
- (a) arrange for the names of the candidates who have equal numbers of votes to be written on similar slips, and
 - (b) then fold the slips so as to prevent the names from being seen, mix the slips and draw one of the slips at random.
- 6.7 The candidate whose name is on the drawn slip is the candidate who is to be the chairperson.
- 6.8 Any election conducted under clause 6.3, and the outcome of the vote, are to be recorded in the minutes of the meeting.

Chairperson to have precedence

- 6.9 When the chairperson rises or speaks during a meeting of council:
- (a) any councillor then speaking or seeking to speak must cease speaking and, if standing, immediately resume their seat, and
 - (b) every councillor present must be silent to enable the chairperson to be heard without interruption.

7. MODES OF ADDRESS

- 7.1 If the chairperson is the mayor, they are to be addressed as 'Mr Mayor' or 'Madam Mayor'.
- 7.2 Where the chairperson is not the mayor, they are to be addressed as either 'Mr Chairperson' or 'Madam Chairperson'.
- 7.3 A councillor is to be addressed as 'Councillor [surname]'.

7.4 A council officer is to be addressed by their official designation or as Mr/Ms [surname].

8. ORDER OF BUSINESS FOR ORDINARY COUNCIL MEETINGS

8.1 The general order of business for an ordinary meeting of council will be:

1. Attendance
2. Welcome
3. Statement of Respect/ Ethical Obligations/ Livestream/ Amenities/ Emergency arrangements

Statement of Respect

The Norfolk Island Regional Council promotes a climate of respect for all. This Council meeting is being streamed live, recorded, and broadcast online and via Norfolk Radio. To those present in the gallery today, by attending or participating in this public meeting you are consenting to your image, voice and comments being recorded and published. The Administrator and/or General Manager have the authority to pause or terminate the stream if comments or debate are considered defamatory or otherwise inappropriate for publishing. Attendees are advised that they may be subject to legal action if they engage in unlawful behaviour or commentary.

Amenities

8.2 The order of business as fixed under clause 8.1 may be altered for a particular meeting of council if a motion to that effect is passed at that meeting. Such a motion can be moved without notice.

8.3 Despite clauses 10.20–10.30, only the mover of a motion referred to in clause 8.2 may speak to the motion before it is put.

8.4 A report covering Work, Health and Safety (WH&S) will be included as a regular report on the Council Meeting Agenda.

9. CONSIDERATION OF BUSINESS AT COUNCIL MEETINGS

Business that can be dealt with at a council meeting

9.1 Council must not consider business at a meeting of council:

- (a) unless a councillor has given notice of the business, as required by clause 3.9, and

- (b) unless notice of the business has been sent to the councillors in accordance with clause 3.6 in the case of an ordinary meeting or clause 3.8 in the case of an extraordinary meeting called in an emergency.

9.2 Clause 9.1 does not apply to the consideration of business at a meeting, if the business:

- (a) is already before, or directly relates to, a matter that is already before council, or
- (b) is the election of a chairperson to preside at the meeting, or
- (c) subject to clause 9.9, is a matter or topic put to the meeting by way of a mayoral minute, or
- (d) is a motion for the adoption of recommendations of a committee, including, but not limited to, a committee of council.

9.3 Despite clause 9.1, business may be considered at a meeting of council even though due notice of the business has not been given to the councillors if:

- (a) a motion is passed to have the business considered at the meeting, and
- (b) the business to be considered is ruled by the chairperson to be of great urgency on the grounds that it requires a decision by council before the next scheduled ordinary meeting of council.

9.4 A motion moved under clause 9.3(a) can be moved without notice. Despite clauses 10.20– 10.30, only the mover of a motion referred to in clause 9.3(a) can speak to the motion before it is put.

9.5 A motion of dissent cannot be moved against a ruling by the chairperson under clause 9.3(b).

Mayoral minutes

9.6 Subject to clause 9.9, if the mayor is the chairperson at a meeting of council, the mayor may, by minute signed by the mayor, put to the meeting without notice any matter or topic that is within the jurisdiction of council, or of which council has official knowledge.

9.7 A mayoral minute, when put to a meeting, takes precedence over all business on council's agenda for the meeting. The chairperson (but only if the chairperson is the mayor) may move the adoption of a mayoral minute without the motion being seconded.

9.8 A recommendation made in a mayoral minute put by the mayor is, so far as it is adopted by council, a resolution of council.

9.9 A mayoral minute must not be used to put without notice matters that are routine and not urgent or matters for which proper notice should be given because of their complexity. For the purpose of this clause, a matter will be urgent where it requires a decision by council before the next scheduled ordinary meeting of council **or is considered by the mayor to have currency and importance.**

9.10 Where a mayoral minute makes a recommendation which, if adopted, would require the expenditure of funds on works and/or services other than those already provided for in council's current adopted operational plan, it must identify the source of funding for the expenditure that is the subject of the recommendation. If the mayoral minute does not identify a funding source, council must defer consideration of the matter,

pending a report from the general manager on the availability of funds for implementing the recommendation if adopted.

Staff reports

- 9.11 A recommendation made in a staff report is, so far as it is adopted by council, a resolution of council.

Reports of committees of council

- 9.12 The recommendations of a committee of council are, so far as they are adopted by council, resolutions of council.
- 9.13 If in a report of a committee of council distinct recommendations are made, council may make separate decisions on each recommendation.

Questions

- 9.14 A question must not be asked at a meeting of council unless it concerns a matter on the agenda of the meeting or notice has been given of the question in accordance with clauses 3.9 and 3.11
- 9.15 A councillor may, through the chairperson, put a question to another councillor about a matter on the agenda.
- 9.16 A councillor may, through the general manager, put a question to a council employee about a matter on the agenda. Council staff are only obliged to answer a question put to them through the general manager at the direction of the general manager.
- 9.17 A councillor or council employee to whom a question is put is entitled to be given reasonable notice of the question and, in particular, sufficient notice to enable reference to be made to other persons or to information. Where a councillor or council employee to whom a question is put is unable to respond to the question at the meeting at which it is put, they may take it on notice and report the response to the next meeting of council.
- 9.18 Councillors must put questions directly, succinctly, respectfully and without argument.
- 9.19 The chairperson must not permit discussion on any reply to, or refusal to reply to, a question put to a councillor or council employee.

10. RULES OF DEBATE

Motions to be seconded

- 10.1 Unless otherwise specified in this code, a motion or an amendment cannot be debated unless or until it has been seconded.

Notices of motion

- 10.2 A councillor who has submitted a notice of motion under clause 3.9 is to move the motion the subject of the notice of motion at the meeting at which it is to be considered.
- 10.3 If a councillor who has submitted a notice of motion under clause 3.9 wishes to withdraw it after the agenda and business paper for the meeting at which it is to be

considered have been sent to councillors, the councillor may request the withdrawal of the motion when it is before council.

- 10.4 In the absence of a councillor who has placed a notice of motion on the agenda for a meeting of council:
- (a) any other councillor may, with the leave of the chairperson, move the motion at the meeting, or
 - (b) the chairperson may defer consideration of the motion until the next meeting of council.

Chairperson's duties with respect to motions

- 10.5 It is the duty of the chairperson at a meeting of council to receive and put to the meeting any lawful motion that is brought before the meeting.
- 10.6 The chairperson must rule out of order any motion or amendment to a motion that is unlawful or the implementation of which would be unlawful.
- 10.7 Before ruling out of order a motion or an amendment to a motion under clause 10.6, the chairperson is to give the mover an opportunity to clarify or amend the motion or amendment.
- 10.8 Any motion, amendment, or other matter that the chairperson has ruled out of order is taken to have been lost.

Motions requiring the expenditure of funds

- 10.9 A motion or an amendment to a motion which if passed would require the expenditure of funds on works and/or services other than those already provided for in council's current adopted operational plan must identify the source of funding for the expenditure that is the subject of the motion. If the motion does not identify a funding source, council must defer consideration of the matter, pending a report from the general manager on the availability of funds for implementing the motion if adopted.

Amendments to motions

- 10.10 An amendment to a motion must be moved and seconded before it can be debated.
- 10.11 An amendment to a motion must relate to the matter being dealt with in the original motion before council and must not be a direct negative of the original motion. An amendment to a motion which does not relate to the matter being dealt with in the original motion, or which is a direct negative of the original motion, must be ruled out of order by the chairperson.
- 10.12 The mover of an amendment is to be given the opportunity to explain any uncertainties in the proposed amendment before a seconder is called for.
- 10.13 If an amendment has been lost, a further amendment can be moved to the motion to which the lost amendment was moved, and so on, but no more than one (1) motion and one (1) proposed amendment can be before council at any one time.
- 10.14 While an amendment is being considered, debate must only occur in relation to the amendment and not the original motion. Debate on the original motion is to be suspended while the amendment to the original motion is being debated.

- 10.15 If the amendment is carried, it becomes the motion and is to be debated. If the amendment is lost, debate is to resume on the original motion.
- 10.16 An amendment may become the motion without debate or a vote where it is accepted by the councillor who moved the original motion.

Foreshadowed motions---TO BE DELETED

- ~~10.17 A councillor may propose a foreshadowed motion in relation to the matter the subject of the original motion before council, without a seconder during debate on the original motion. The foreshadowed motion is only to be considered if the original motion is lost or withdrawn and~~
- ~~the foreshadowed motion is then moved and seconded. If the original motion is carried, the foreshadowed motion lapses.~~
- ~~10.18 Where an amendment has been moved and seconded, a councillor may, without a seconder, foreshadow a further amendment that they propose to move after the first amendment has been dealt with. There is no limit to the number of foreshadowed amendments that may be put before council at any time. However, no discussion can take place on foreshadowed amendments until the previous amendment has been dealt with and the foreshadowed amendment has been moved and seconded.~~
- ~~10.19 Foreshadowed motions and foreshadowed amendments are to be considered in the order in which they are proposed. However, foreshadowed motions cannot be considered until all foreshadowed amendments have been dealt with.~~

Limitations on the number and duration of speeches

- 10.20 A councillor who, during a debate at a meeting of council, moves an original motion, has the right to speak on each amendment to the motion and a right of general reply to all observations that are made during the debate in relation to the motion, and any amendment to it at the conclusion of the debate before the motion (whether amended or not) is finally put.
- 10.21 A councillor, other than the mover of an original motion, has the right to speak once on the motion and once on each amendment to it.
- 10.22 A councillor must not, without the consent of council, speak more than once on a motion or an amendment, or for longer than five (5) minutes at any one time.
- 10.23 Despite clause 10.22, the chairperson may permit a councillor who claims to have been misrepresented or misunderstood to speak more than once on a motion or an amendment, and for longer than five (5) minutes on that motion or amendment to enable the councillor to make a statement limited to explaining the misrepresentation or misunderstanding.
- 10.24 Despite clauses 10.20 and 10.21, a councillor may move that a motion or an amendment be now put:
- (a) if the mover of the motion or amendment has spoken in favour of it and no councillor expresses an intention to speak against it, or
 - (b) if at least two (2) councillors have spoken in favour of the motion or amendment and at least two (2) councillors have spoken against it.

- 10.25 The chairperson must immediately put to the vote, without debate, a motion moved under clause 10.25. A seconder is not required for such a motion.
- 10.26 If a motion that the original motion or an amendment be now put is passed, the chairperson must, without further debate, put the original motion or amendment to the vote immediately after the mover of the original motion has exercised their right of reply under clause 10.20.
- 10.27 If a motion that the original motion or an amendment be now put is lost, the chairperson must allow the debate on the original motion or the amendment to be resumed.
- 10.28 All councillors must be heard without interruption and all other councillors must, unless otherwise permitted under this code, remain silent while another councillor is speaking.
- 10.29 Once the debate on a matter has concluded and a matter has been dealt with, the chairperson must not allow further debate on the matter.
- 10.30 Clause 10.29 does not prevent a further motion from being moved on the same item of business where the original motion is lost provided the motion is not substantially the same as the one that is lost.

11. VOTING

Voting entitlements of councillors

- 11.1 Each councillor is entitled to one (1) vote.

Clause 11.1 reflects section 370(1) of the Act.

- 11.2 The person presiding at a meeting of council has, in the event of an equality of votes, a second or casting vote.

Clause 11.2 reflects section 370(2) of the Act.

- 11.3 Where the chairperson declines to exercise, or fails to exercise, their second or casting vote, in the event of an equality of votes, the motion being voted upon is lost.

Voting at council meetings

- 11.4 A councillor who is present at a meeting of council but who fails to vote on a motion put to the meeting is taken to have voted against the motion.
- 11.5 Voting at a meeting, including voting in an election at a meeting, is to be by open means (such as on the voices, by show of hands or by a visible electronic voting system). However, council may resolve that the voting in any election by councillors for mayor or deputy mayor is to be by secret ballot.
- 11.6 All voting at council meetings, (including meetings that are closed to the public), must be recorded in the minutes of meetings with the names of councillors who voted for and against each motion or amendment, (including the use of the casting vote), being recorded.

Voting on planning decisions

11.7 The council or a council committee must not make a final planning decision

without receiving a staff report containing an assessment and recommendation in relation to the matter put before the council for a decision.

- 11.8 Where the council or a council committee makes a planning decision that is inconsistent with the recommendation made in a staff report, it must provide reasons for its decision and why it did not adopt the staff recommendation.**
- 11.9 The general manager must keep a register containing, for each planning decision made at a meeting of council or a council committee (including, but not limited to a committee of council), the names of the councillors who supported the decision and the names of any councillors who opposed (or are taken to have opposed) the decision.
- 11.10 Each decision recorded in the register is to be described in the register or identified in a manner that enables the description to be obtained from another publicly available document.
- 11.11 Clauses 11.9–11.10 apply also to meetings that are closed to the public.

Clauses 11.9–11.11 reflect section 375A of the Act.

The requirements of clause 11.9 may be satisfied by maintaining a register of the minutes of each planning decision.

12. COMMITTEE OF THE WHOLE

- 12.1 Council may resolve itself into a committee to consider any matter before council.
- Clause 12.1 reflects section 373 of the Act.*
- 12.2 All the provisions of this code relating to meetings of council, so far as they are applicable, extend to and govern the proceedings of council when in committee of the whole, except the provisions limiting the number and duration of speeches.
- Clauses 10.20–10.30 limit the number and duration of speeches.*
- 12.3 The general manager or, in the absence of the general manager, an employee of council designated by the general manager, is responsible for reporting to council the proceedings of the committee of the whole. It is not necessary to report the proceedings in full, but any recommendations of the committee must be reported.
- 12.4 Council must ensure that a report of the proceedings (including any recommendations of the committee) is recorded in council's minutes. However, council is not taken to have adopted the report until a motion for adoption has been made and passed.

13. CLOSURE OF COUNCIL MEETINGS TO THE PUBLIC

Grounds on which meetings can be closed to the public

- 13.1 Council or a committee of council may close to the public so much of its meeting as comprises the discussion or the receipt of any of the following types of matters:

- (a) personnel matters concerning particular individuals (other than councillors),
- (b) the personal hardship of any resident or ratepayer,
- (c) information that would, if disclosed, confer a commercial advantage on a person with whom council is conducting (or proposes to conduct) business,
- (d) commercial information of a confidential nature that would, if disclosed:
 - (i) prejudice the commercial position of the person who supplied it, or
 - (ii) confer a commercial advantage on a competitor of council, or
 - (iii) reveal a trade secret,
- (e) information that would, if disclosed, prejudice the maintenance of law,
- (f) matters affecting the security of council, councillors, council staff or council property,
- (g) advice concerning litigation, or advice that would otherwise be privileged from production in legal proceedings on the ground of legal professional privilege,
- (h) information concerning the nature and location of a place or an item of Aboriginal significance on community land,
- (i) alleged contraventions of council's code of conduct.

Clause 13.1 reflects section 10A(1) and (2) of the Act.

- 13.2 Council or a committee of council may also close to the public so much of its meeting as comprises a motion to close another part of the meeting to the public

Clause 13.2 reflects section 10A(3) of the Act.

Matters to be considered when closing meetings to the public

- 13.3 A meeting is not to remain closed during the discussion of anything referred to in clause 13.1:

- (a) except for so much of the discussion as is necessary to preserve the relevant confidentiality, privilege or security, and
- (b) if the matter concerned is a matter other than a personnel matter concerning particular individuals, the personal hardship of a resident or ratepayer or a trade secret – unless council or committee concerned is satisfied that discussion of the matter in an open meeting would, on balance, be contrary to the public interest.

Clause 13.3 reflects section 10B(1) of the Act.

- 13.4 A meeting is not to be closed during the receipt and consideration of information or advice referred to in clause 13.1(g) unless the advice concerns legal matters that:

- (a) are substantial issues relating to a matter in which council or committee is involved,
- (b) are clearly identified in the advice, and

- (c) are fully discussed in that advice.

Clause 13.4 reflects section 10B(2) of the Act.

- 13.5 If a meeting is closed during the discussion of a motion to close another part of the meeting to the public (as referred to in clause 13.2), the consideration of the motion must not include any consideration of the matter or information to be discussed in that other part of the meeting other than consideration of whether the matter concerned is a matter referred to in clause 13.1.

Clause 13.5 reflects section 10B(3) of the Act.

- 13.6 For the purpose of determining whether the discussion of a matter in an open meeting would be contrary to the public interest, it is irrelevant that: (a) a person may misinterpret or misunderstand the discussion, or

(b) the discussion of the matter may:

- (i) cause embarrassment to council or committee concerned, or to councillors or to employees of council, or
- (ii) cause a loss of confidence in council or a committee.

Clause 13.6 reflects section 10B(4) of the Act.

- 13.7 In deciding whether part of a meeting is to be closed to the public, council or the committee concerned must consider any relevant guidelines issued by the Departmental Chief Executive of the NSW Office of Local Government.

Clause 13.7 reflects section 10B(5) of the Act.

Notice of likelihood of closure not required in urgent cases

- 13.8 Part of a meeting of council, or of a committee of council, may be closed to the public while council or committee considers a matter that has not been identified in the agenda for the meeting under clause 3.18 as a matter that is likely to be considered when the meeting is closed, but only if:

- (a) it becomes apparent during the discussion of a particular matter that the matter is a matter referred to in clause 13.1, and
- (b) council or committee, after considering any representations made under clause 13.9, resolves that further discussion of the matter:
 - (i) should not be deferred (because of the urgency of the matter),and
 - (ii) should take place in a part of the meeting that is closed to the public.

Clause 13.8 reflects section 10C of the Act.

Representations by members of the public

- 13.9 Council, or a committee of council, may allow members of the public to make representations to or at a meeting, before any part of the meeting is closed to the public, as to whether that part of the meeting should be closed.

Clause 13.9 reflects section 10A(4) of the Act.

- 13.10 A representation under clause 13.9 is to be made after the motion to close the part of the meeting is moved and seconded.
- 13.11 Where the matter has been identified in the agenda of the meeting under clause 3.18 as a matter that is likely to be considered when the meeting is closed to the public, in order to make representations under clause 13.9, members of the public must first make an application to council in the approved form. Applications must be received by Monday 4:30pm before the meeting at which the matter is to be considered.
- 13.12 The general manager (or their delegate) may refuse an application made under clause 13.11. The general manager or their delegate must give reasons in writing for a decision to refuse an application.
- 13.13 No more than four (4) speakers are to be permitted to make representations under clause 13.9.
- 13.14 If more than the permitted number of speakers apply to make representations under clause 13.9, the general manager or their delegate may request the speakers to nominate from among themselves the persons who are to make representations to council. If the speakers are not able to agree on whom to nominate to make representations under clause 13.9, the general manager or their delegate is to determine who will make representations to council.
- 13.15 The general manager (or their delegate) is to determine the order of speakers.
- 13.16 Where council or a committee of council proposes to close a meeting or part of a meeting to the public in circumstances where the matter has not been identified in the agenda for the meeting under clause 3.18 as a matter that is likely to be considered when the meeting is closed to the public, the chairperson is to invite representations from the public under clause 13.9 after the motion to close the part of the meeting is moved and seconded. The chairperson is to permit no more than four (4) speakers to make representations in such order as determined by the chairperson.
- 13.17 Each speaker will be allowed five (5) minutes to make representations, and this time limit is to be strictly enforced by the chairperson. Speakers must confine their representations to whether the meeting should be closed to the public. If a speaker digresses to irrelevant matters, the chairperson is to direct the speaker not to do so. If a speaker fails to observe a direction from the chairperson, the speaker will not be further heard.

Expulsion of non-councillors from meetings closed to the public

- 13.18 If a meeting or part of a meeting of council or a committee of council is closed to the public in accordance with section 10A of the Act and this code, any person who is not a councillor and who fails to leave the meeting when requested, may be expelled from the meeting as provided by section 10(2)(a) or (b) of the Act.

- 13.19 If any such person, after being notified of a resolution or direction expelling them from the meeting, fails to leave the place where the meeting is being held, a police officer, or any person authorised for the purpose by council or person presiding, may, by using only such force as is necessary, remove the first-mentioned person from that place and, if necessary restrain that person from re-entering that place for the remainder of the meeting.

Obligations of councillors attending meetings by audio-visual link

- 13.20 Councillors attending a meeting by audio-visual link must ensure that no other person is within sight or hearing of the meeting at any time that the meeting is closed to the public under section 10A of the Act.

Information to be disclosed in resolutions closing meetings to the public

- 13.21 The grounds on which part of a meeting is closed must be stated in the decision to close that part of the meeting and must be recorded in the minutes of the meeting. The grounds must specify the following:
- (a) the relevant provision of section 10A(2) of the Act,
 - (b) the matter that is to be discussed during the closed part of the meeting,
 - (c) the reasons why the part of the meeting is being closed, including (if the matter concerned is a matter other than a personnel matter concerning particular individuals, the personal hardship of a resident or ratepayer or a trade secret) an explanation of the way in which discussion of the matter in an open meeting would be, on balance, contrary to the public interest.

Clause 13.20 reflects section 10D of the Act.

Agenda and other reports provided to Councillors for a closed meeting

- 13.22 Documents provided to Councillors for the purposes of a closed meeting may be retained by each Councillor at their discretion and kept in a safe place but may not be divulged to the public.
- 13.23 All confidential documents provided to each Councillor will be individually marked with their name as a watermark.

Resolutions passed at closed meetings to be made public

- 13.24 If council passes a resolution during a meeting, or a part of a meeting, that is closed to the public, the chairperson must make the resolution public as soon as practicable after the meeting, or the relevant part of the meeting, has ended, and the resolution must be recorded in the publicly available minutes of the meeting.
- 13.25 Resolutions passed during a meeting, or a part of a meeting, that is closed to the public must be made public by the chairperson under clause 13.23 during a part of the meeting that is webcast.
- 13.26 The general manager must cause business papers for items of business considered during a meeting, or part of a meeting, that is closed to public, to be published on the council's website as soon as practicable after the information contained in the business papers ceases to be confidential.**

- 13.27 The general manager must consult with the council and any other affected persons before publishing information on the council's website under clause 14.19 and provide reasons for why the information has ceased to be confidential.**

14. KEEPING ORDER AT MEETINGS

Points of order

- 14.1 A councillor may draw the attention of the chairperson to an alleged breach of this code by raising a point of order. A point of order does not require a seconder.
- 14.2 A point of order cannot be made with respect to adherence to the principles contained in clause 2.1.
- 14.3 A point of order must be taken immediately it is raised. The chairperson must suspend the business before the meeting and permit the councillor raising the point of order to state the provision of this code they believe has been breached. The chairperson must then rule on the point of order – either by upholding it or by overruling it.

Questions of order

- 14.4 The chairperson, without the intervention of any other councillor, may call any councillor to order whenever, in the opinion of the chairperson, it is necessary to do so.
- 14.5 A councillor who claims that another councillor has committed an act of disorder, or is out of order, may call the attention of the chairperson to the matter.
- 14.6 The chairperson must rule on a question of order immediately after it is raised but, before doing so, may invite the opinion of council.
- 14.7 The chairperson's ruling must be obeyed unless a motion dissenting from the ruling is passed.

Motions of dissent

- 14.8 A councillor can, without notice, move to dissent from a ruling of the chairperson on a point of order or a question of order. If that happens, the chairperson must suspend the business before the meeting until a decision is made on the motion of dissent.
- 14.9 If a motion of dissent is passed, the chairperson must proceed with the suspended business as though the ruling dissented from had not been given. If, as a result of the ruling, any motion or business has been rejected as out of order, the chairperson must restore the motion or business to the agenda and proceed with it in due course.
- 14.10 Despite any other provision of this code, only the mover of a motion of dissent and the chairperson can speak to the motion before it is put. The mover of the motion does not have a right of general reply.

Acts of disorder

14.11 A councillor commits an act of disorder if the councillor, at a meeting of council or a committee of council:

- (a) contravenes the Act or any regulation in force under the Act or this code, or
- (b) assaults or threatens to assault another councillor or person present at the meeting, or
- (c) moves or attempts to move a motion or an amendment that has an unlawful purpose or that deals with a matter that is outside the jurisdiction of council or the committee, or addresses or attempts to address council or the committee on such a motion, amendment or matter, or
- (d) insults or makes unfavourable personal remarks about or imputes improper motives to any other council official, or alleges a breach of council's code of conduct, or
- (e) says or does anything that is inconsistent with maintaining order at the meeting or is likely to bring council or the committee into disrepute.
- (f) **uses offensive or disorderly words, or**
- (g) **makes gestures or otherwise behaves in a way that is sexist, racist, homophobic or otherwise discriminatory, or, if the behaviour occurred in the Legislative Assembly, would be considered disorderly, or**
- (h) **imputes improper motives to or unfavourably personally reflects upon any other council official, or a person present at the meeting, except by a motion, or**
- (i) **says or does anything that would promote disorder at the meeting or is otherwise inconsistent with maintaining order at the meeting.**

Note: Clause 14.11 reflects section 182 of the Regulation.

Note: The Legislative Assembly's Speaker's Guidelines state that "Members are not to use language, make gestures, or behave in any way in the Chamber that is sexist, racist, homophobic or otherwise exclusionary or discriminatory. Such conduct may be considered offensive and disorderly, in accordance with Standing Order 74".

14.12 The chairperson may require a councillor:

- (a) to apologise without reservation for an act of disorder referred to in clauses 14.11(a) or (b), or
- (b) to withdraw a motion or an amendment referred to in clause 14.11(c) and, where appropriate, to apologise without reservation, or
- (c) to retract and apologise without reservation for an act of disorder referred to in clauses 14.11(d) and (e).

Note: Clause 14.12 reflects section 233 of the Regulation.

- 14.13 A failure to comply with a requirement under clause 14.12 constitutes a fresh act of disorder for the purposes of clause 14.11**
- 14.14 Where a councillor fails to take action in response to a requirement by the chairperson to remedy an act of disorder under clause 14.12 at the meeting at which the act of disorder occurred, the chairperson may require the councillor to take that action at each subsequent meeting until such time as the councillor complies with the requirement. If the councillor fails to remedy the act of disorder at a subsequent meeting, they may be expelled from the meeting under clause 14.16.**

How disorder at a meeting may be dealt with

- 14.13 If disorder occurs at a meeting of council, the chairperson may adjourn the meeting for a period of not more than fifteen (15) minutes and leave the chair. Council, on reassembling, must, on a question put from the chairperson, decide without debate whether the business is to be proceeded with or not. This clause applies to disorder arising from the conduct of members of the public as well as disorder arising from the conduct of councillors.

Expulsion from meetings

- 14.14 All chairpersons of meetings of council and committees of council are authorised under this code to expel any person, including any councillor, from a council or committee meeting, for the purposes of section 10(2)(b) of the Act.
- 14.15 Clause 14.14, does not limit the ability of council or a committee of council to resolve to expel a person, including a councillor, from a council or committee meeting, under section 10(2)(a) of the Act.
- 14.16 A councillor may, as provided by section 10(2)(a) or (b) of the Act, be expelled from a meeting of council for having failed to comply with a requirement under clause 14.12. The expulsion of a councillor from the meeting for that reason does not prevent any other action from being taken against the councillor for the act of disorder concerned.

Note: Clause 14.16 reflects section 233(2) of the Regulation.

- 14.17 A member of the public may, as provided by section 10(2)(a) or (b) of the Act, be expelled from a meeting of council for engaging in or having engaged in disorderly conduct at the meeting.
- 14.18 Where a councillor or a member of the public is expelled from a meeting, the expulsion and the name of the person expelled, if known, are to be recorded in the minutes of the meeting.
- 14.19 If a councillor or a member of the public fails to leave the place where a meeting of council is being held immediately after they have been expelled, a police officer, or any person authorised for the purpose by council or person presiding, may, by using only such force as is necessary, remove the councillor or member of the public from that place and, if necessary, restrain the councillor or member of the public from re-entering that place for the remainder of the meeting.

How disorder by councillors attending meetings by audio-visual link may be dealt with

- 14.20 Where a councillor is attending a meeting by audio-visual link, the chairperson or a person authorised by the chairperson may mute the councillor's audio link to the meeting for the purposes of enforcing compliance with this code.
- 14.21 If a councillor attending a meeting by audio-visual link is expelled from a meeting for an act of disorder, the chairperson of the meeting or a person authorised by the chairperson, may terminate the councillor's audio-visual link to the meeting.

Use of mobile phones and the unauthorised recording of meetings

- 14.22 Councillors, council staff and members of the public must ensure that mobile phones are switched to silent during meetings of council and committees of council.
- 14.23 A person must not live stream or use an audio recorder, video camera, mobile phone or any other device to make a recording of the proceedings of a meeting of council or a committee of council without the prior authorisation of council or the committee.
- 14.24 Without limiting clause 14.17, a contravention of clause 14.21 or an attempt to contravene that clause, constitutes disorderly conduct for the purposes of clause 14.17. Any person who contravenes or attempts to contravene clause 14.21, may be expelled from the meeting as provided for under section 10(2) of the Act.
- 14.25 If any such person, after being notified of a resolution or direction expelling them from the meeting, fails to leave the place where the meeting is being held, a police officer, or any person authorised for the purpose by council or person presiding, may, by using only such force as is necessary, remove the first-mentioned person from that place and, if necessary, restrain that person from re-entering that place for the remainder of the meeting.

15. CONFLICTS OF INTEREST

- 15.1 All councillors and, where applicable, all other persons, must declare and manage any conflicts of interest they may have in matters being considered at meetings of council and committees of council in accordance with council's code of conduct. All declarations of conflicts of interest and how the conflict of interest was managed by the person who made the declaration must be recorded in the minutes of the meeting at which the declaration was made.
- 15.2 Councillors attending a meeting by audio-visual link must declare and manage any conflicts of interest they may have in matters being considered at the meeting in accordance with council's code of conduct. Where a councillor has declared a pecuniary or significant nonpecuniary conflict of interest in a matter being discussed at the meeting, the councillor's audio-visual link to the meeting must be suspended or terminated and the councillor must not be in sight or hearing of the meeting at any time during which the matter is being considered or discussed by the council or committee, or at any time during which council or committee is voting on the matter.

16. DECISIONS OF COUNCIL

Council decisions

- 16.1 A decision supported by a majority of the votes at a meeting of council at which a quorum is present is a decision of council.

Clause 16.1 reflects section 371 of the Act.

- 16.2 Decisions made by council must be accurately recorded in the minutes of the meeting at which the decision is made.

Rescinding or altering council decisions

- 16.3 A resolution passed by council may not be altered or rescinded except by a motion to that effect of which notice has been given under clause 3.9.

Clause 16.3 reflects section 372(1) of the Act.

- 16.4 If a notice of motion to rescind a resolution is given at the meeting at which the resolution is carried, the resolution must not be carried into effect until the motion of rescission has been dealt with.

Clause 16.4 reflects section 372(2) of the Act.

- 16.5 If a motion has been lost, a motion having the same effect must not be considered unless notice of it has been duly given in accordance with clause 3.9.

Clause 16.5 reflects section 372(3) of the Act.

- 16.6 A notice of motion to alter or rescind a resolution, and a notice of motion which has the same effect as a motion which has been lost, must be signed by three (3) councillors if less than three (3) months has elapsed since the resolution was passed, or the motion was lost. *Clause 16.6 reflects section 372(4) of the Act.*

- 16.7 If a motion to alter or rescind a resolution has been lost, or if a motion which has the same effect as a previously lost motion is lost, no similar motion may be brought forward within three (3) months of the meeting at which it was lost. This clause may not be evaded by substituting a motion differently worded, but in principle the same.

Clause 16.7 reflects section 372(5) of the Act.

- 16.8 The provisions of clauses 16.5–16.7 concerning lost motions do not apply to motions of adjournment.

Clause 16.8 reflects section 372(7) of the Act.

- 16.9 A notice of motion submitted in accordance with clause 16.6 may only be withdrawn under clause 3.10 with the consent of all signatories to the notice of motion.

- 16.10 A notice of motion to alter or rescind a resolution relating to a development application must be submitted to the general manager no later than 1 day after the meeting at which the resolution was adopted.**

- 16.10 A motion to alter or rescind a resolution of council may be moved on the report of a committee of council and any such report must be recorded in the minutes of the meeting of council.

Clause 16.10 reflects section 372(6) of the Act.

- 16.11 Subject to clause 16.7, in cases of urgency, a motion to alter or rescind a resolution of council may be moved at the same meeting at which the resolution was adopted, where:

- (a) a notice of motion signed by three councillors is submitted to the chairperson, and
- (b) a motion to have the motion considered at the meeting is passed, and
- (c) the chairperson rules the business that is the subject of the motion is of great urgency on the grounds that it requires a decision by council before the next scheduled ordinary meeting of council.

- 16.12 A motion moved under clause 16.11(b) can be moved without notice. Despite clauses 10.20– 10.30, only the mover of a motion **and the Chairperson/The Mayor, if they are not the mover of the motion** referred to in clause 16.11(b) can speak to the motion before it is put.

- 16.13 A motion of dissent cannot be moved against a ruling by the chairperson under clause 16.11(c).

Recommitting resolutions to correct an error

- 16.14 Despite the provisions of this Part, a councillor may, with the leave of the chairperson, move to recommit a resolution adopted at the same meeting:

- (a) to correct any error, ambiguity or imprecision in council's resolution, or
- (b) to confirm the voting on the resolution.

- 16.15 In seeking the leave of the chairperson to move to recommit a resolution for the purposes of clause 16.14(a), the councillor is to propose alternative wording for the resolution.

- 16.16 The chairperson must not grant leave to recommit a resolution for the purposes of clause 16.14(a), unless they are satisfied that the proposed alternative wording of the resolution would not alter the substance of the resolution previously adopted at the meeting.

- 16.17 A motion moved under clause 16.14 can be moved without notice. Despite clauses 10.20– 10.30, only the mover of a motion referred to in clause 16.14 and the chairperson, if they are not the mover of the motion, can speak to the motion before it is put.

- 16.18 A motion of dissent cannot be moved against a ruling by the chairperson under clause 16.14.

- 16.19 A motion moved under clause 16.14 with the leave of the chairperson cannot be voted on unless or until it has been seconded.

17. TIME LIMITS ON COUNCIL MEETINGS

- 17.1 Meetings of the council and committees of the council are to conclude at a time the council may from time to time determine.
- 17.2 A short break of not less than 10 minutes is to be taken within the first three hours at each ordinary and extraordinary meeting of council and committees of the council.
- 17.3 If the business of the meeting is unfinished at the time the council has determined, and the council does not resolve to extend the meeting, the chairperson must either:
- (a) defer consideration of the remaining items of business on the agenda to the next ordinary meeting of the council, or
 - (b) adjourn the meeting to a time, date and place fixed by the chairperson.
- 17.4 Clause 17.2 does not limit the ability of the council or a committee of the council to resolve to adjourn a meeting at any time. The resolution adjourning the meeting must fix the time, date and place that the meeting is to be adjourned to.
- 17.5 Where a meeting is adjourned under clause 17.2 or 17.3, the general manager must:
- (a) individually notify each councillor of the time, date and place at which the meeting will reconvene, and
 - (b) publish the time, date and place at which the meeting will reconvene on the council's website and in such other manner that the general manager is satisfied is likely to bring notice of the time, date and place of the reconvened meeting to the attention of as many people as possible.

18. AFTER THE MEETING

Minutes of meetings

- 18.1 Council is to keep full and accurate minutes of the proceedings of meetings of council.

Clause 17.1 reflects section 375(1) of the Act.

- 18.2 At a minimum, the general manager must ensure that the following matters are recorded in council's minutes:
- (a) the names of councillors attending a council meeting and whether they attended the meeting in person or by audio-visual link,
 - (b) details of each motion moved at a council meeting and of any amendments moved to it,
 - (c) the names of the mover and seconder of the motion or amendment,
 - (d) whether the motion or amendment was passed or lost, and
 - (e) such other matters specifically required under this code.

- 18.3 The minutes of a council meeting must be confirmed at a subsequent meeting of council.

Clause 17.3 reflects section 375(2) of the Act.

18.4 Any debate on the confirmation of the minutes is to be confined to whether the minutes are a full and accurate record of the meeting they relate to.

18.5 When the minutes have been confirmed, they are to be signed by the person presiding at the subsequent meeting.

Clause 17.5 reflects section 375(2) of the Act.

18.6 The confirmed minutes of a meeting may be amended to correct typographical or administrative errors after they have been confirmed. Any amendment made under this clause must not alter the substance of any decision made at the meeting.

18.7 The confirmed minutes of a council meeting must be published on council's website. This clause does not prevent council from also publishing unconfirmed minutes of its meetings on its website prior to their confirmation.

Access to correspondence and reports laid on the table at, or submitted to, a meeting

- 18.8 Council and committees of council must, during or at the close of a meeting, or during the business day following the meeting, give reasonable access to any person to inspect correspondence and reports laid on the table at, or submitted to, the meeting.

Clause 17.8 reflects section 11(1) of the Act.

- 18.9 Clause 17.8 does not apply if the correspondence or reports relate to a matter that was received or discussed or laid on the table at, or submitted to, the meeting when the meeting was closed to the public.

Clause 17.9 reflects section 11(2) of the Act.

- 18.10 Clause 17.8 does not apply if council or the committee resolves at the meeting, when open to the public, that the correspondence or reports are to be treated as confidential because they relate to a matter specified in section 10A(2) of the Act.

Clause 17.10 reflects section 11(3) of the Act.

- 18.11 Correspondence or reports to which clauses 17.9 and 17.10 apply are to be marked with the relevant provision of section 10A(2) of the Act that applies to the correspondence or report.

Implementation of decisions of council

- 18.12 The general manager is to implement, without undue delay, lawful decisions of council.

Clause 17.12 reflects section 335(b) of the Act.

19. COUNCIL COMMITTEES

Application of this Part

- 18.1 This Part only applies to committees of council whose members are all councillors.

Council committees whose members are all councillors

19.2 Council may, by resolution, establish such committees as it considers necessary.

19.3 A committee of council is to consist of the mayor and such other councillors as are elected by the councillors or appointed by council.

19.4 The quorum for a meeting of a committee of council is to be:

- (a) such number of members as council decides, or
- (b) if council has not decided a number – a majority of the members of the committee.

Functions of committees

19.5 Council must specify the functions of each of its committees when the committee is established but may from time to time amend those functions.

Notice of committee meetings

19.6 The general manager must send to each councillor, regardless of whether they are a committee member, at least three (3) days before each meeting of the committee, a notice specifying:

- (a) the time, date and place of the meeting, and
- (b) the business proposed to be considered at the meeting.

19.7 Notice of less than three (3) days may be given of a committee meeting called in an emergency.

Attendance at committee meetings

19.8 A committee member (other than the mayor) ceases to be a member of a committee if the committee member:

- (a) has been absent from three (3) consecutive meetings of the committee without having given reasons acceptable to the committee for the member's absences, or
- (b) has been absent from at least half of the meetings of the committee held during the immediately preceding year without having given to the committee acceptable reasons for the member's absences.

19.9 Clause 18.8 does not apply if all of the members of council are members of the committee.

Non-members entitled to attend committee meetings

19.10 A councillor who is not a member of a committee of council is entitled to attend, and to speak at a meeting of the committee. However, the councillor is not entitled:

- (a) to give notice of business for inclusion in the agenda for the meeting, or
- (b) to move or second a motion at the meeting, or
- (c) to vote at the meeting.

Chairperson and deputy chairperson of council committees

19.11 The chairperson of each committee of council must be:

- (a) the mayor, or
- (b) if the mayor does not wish to be the chairperson of a committee, a member of the committee elected by council, or
- (c) if council does not elect such a member, a member of the committee elected by the committee.

19.12 Council may elect a member of a committee of council as deputy chairperson of the committee. If council does not elect a deputy chairperson of such a committee, the committee may elect a deputy chairperson.

19.13 If neither the chairperson nor the deputy chairperson of a committee of council is able or willing to preside at a meeting of the committee, the committee must elect a member of the committee to be acting chairperson of the committee.

19.14 The chairperson is to preside at a meeting of a committee of council. If the chairperson is unable or unwilling to preside, the deputy chairperson (if any) is to preside at the meeting, but if neither the chairperson nor the deputy chairperson is able or willing to preside, the acting chairperson is to preside at the meeting.

Procedure in committee meetings

19.15 Subject to any specific requirements of this code, each committee of council may regulate its own procedure. The provisions of this code are to be taken to apply to all committees of council unless council or the committee determines otherwise in accordance with this clause.

19.16 Whenever the voting on a motion put to a meeting of the committee is equal, the chairperson of the committee is to have a casting vote as well as an original vote unless council or the committee determines otherwise in accordance with clause 18.15.

19.17 Voting at a council committee meeting is to be by open means (such as on the voices, by show of hands or by a visible electronic voting system).

Closure of committee meetings to the public

19.18 The provisions of the Act and Part 14 of this code apply to the closure of meetings of committees of council to the public in the same way they apply to the closure of meetings of council to the public.

19.19 If a committee of council passes a resolution, or makes a recommendation, during a meeting, or a part of a meeting that is closed to the public, the chairperson must make the resolution or recommendation public as soon as practicable after the meeting or part of the meeting has ended, and report the resolution or recommendation to the next meeting of council. The resolution or recommendation must also be recorded in the publicly available minutes of the meeting.

19.20 Resolutions passed during a meeting, or a part of a meeting that is closed to the public must be made public by the chairperson under clause 18.19 during a part of the meeting that is webcast.

Disorder in committee meetings

- 19.21 The provisions of the Act and this code relating to the maintenance of order in council meetings apply to meetings of committees of council in the same way as they apply to meetings of council.

Minutes of council committee meetings

- 19.22 Each committee of council is to keep full and accurate minutes of the proceedings of its meetings. At a minimum, a committee must ensure that the following matters are recorded in the committee's minutes:
- (a) the names of councillors attending a meeting and whether they attended the meeting in person or by audio-visual link,
 - (b) details of each motion moved at a meeting and of any amendments moved to it,
 - (c) the names of the mover and seconder of the motion or amendment,
 - (d) whether the motion or amendment was passed or lost, and
 - (e) such other matters specifically required under this code.
- 19.23 All voting at meetings of committees of council (including meetings that are closed to the public), must be recorded in the minutes of meetings with the names of councillors who voted for and against each motion or amendment, (including the use of the casting vote), being recorded.
- 19.24 The minutes of meetings of each committee of council must be confirmed at a subsequent meeting of the committee. **Until such time that the minutes have been confirmed, the words 'Unconfirmed' are added via a watermark prior to publishing on Councils website. This watermark is removed from the minutes once they are confirmed.**
- 19.25 Any debate on the confirmation of the minutes is to be confined to whether the minutes are a full and accurate record of the meeting they relate to.
- 19.26 When the minutes have been confirmed, they are to be signed by the person presiding at that subsequent meeting.
- 19.27 The confirmed minutes of a meeting may be amended to correct typographical or administrative errors after they have been confirmed. Any amendment made under this clause must not alter the substance of any decision made at the meeting.
- 19.28 The confirmed minutes of a meeting of a committee of council must be published on council's website. This clause does not prevent council from also publishing unconfirmed minutes of meetings of committees of council on its website prior to their confirmation.

20. IRREGULARITIES

- 20.1 Proceedings at a meeting of a council or a council committee are not invalidated because of:
- (a) a vacancy in a civic office, or

- (b) a failure to give notice of the meeting to any councillor or committee member, or
- (c) any defect in the election or appointment of a councillor or committee member, or
- (d) a failure of a councillor or a committee member to declare a conflict of interest, or to refrain from the consideration or discussion of, or vote on, the relevant matter, at a council or committee meeting in accordance with council's code of conduct, or
- (e) a failure to comply with this code.

Clause 19.1 reflects section 374 of the Act.

21. ADVISORY COMMITTEES

Advisory Committees – Guidelines

In accordance with section 355 of the Act, council is able to delegate some of its functions to a committee of council. Council uses this delegation and appoints community people to provide advice, manage facilities or functions through an advisory committee of council.

It is good practice for Council to nominate a Councillor (or more) and a staff member (or more) to participate on the advisory committee. Other Councillors may attend the regular meetings of the

Committees to enable them to gauge the areas of interest or concern of the citizens of the Island.

Council encourages community participation in a number of its functions. One way in which residents can become involved is by becoming a member of an advisory committee for one of council's facilities or functions.

- (a) The appointment of advisory committees is at the discretion of council. The committees are appointed and reappointed in accordance with the Act.
- (b) Advisory committees are formally appointed by the council in office, therefore all advisory committees will be reviewed by the newly appointed council. All current members will remain to hold office until a determination is made by council.
- (c) Council aims to appoint representatives of the local community or interest group to the committee.
- (d) To hold office, all committee members must be appointed by council and for the duration of the term of council.
- (e) Vacancies occurring during the term of council will be advertised and ratified by the Committee prior to recommendation and adoption by council.
- (f) Council must appoint new members before they are able to take part in the committee meetings.
- (g) All nominations for advisory committees are formally submitted in writing to council for appointment.
- (h) Members of advisory committees of council are volunteers; therefore, do not receive payment for services.

- (i) All members must be informed of, and abide by, council's Code of Conduct.
- (j) All committees should have their membership for the term of council unless council has approved otherwise.
- (k) All committees should have a quorum of 50 per cent plus one (1) unless council has approved otherwise.
- (l) All committees shall meet, as a minimum, quarterly (every three (3) months) unless council has approved otherwise.
- (m) All committees shall be chaired by the mayor or a nominated councillor unless council or the committee has approved otherwise.
- (n) All committees shall have a terms of reference clearly stating the purpose and role of the committee.
- (o) The role of the delegated councillor is to represent council on the committee and to assist community members with the formulation of recommendations to council for consideration.
- (p) The general manager may attend any of the committee meetings but does not hold voting rights and shall nominate at least one staff member for each committee.
- (q) The role of the staff member is to arrange for the agenda and minutes and to provide professional specialist advice to the committee. Staff do not have voting rights.
- (r) The role of the staff member may also be to carry out any reasonable action and recommendations of the committee, but only once adopted by council.
- (s) All activities conducted by any of the advisory committees of council are to be in line with council's adopted Integrated Planning and Reporting Framework.
- (t) If there is no quorum, the committee may hold an informal meeting and take notes if so decided by the chairperson. No action or recommendations can be made at such an informal meeting.
- (u) The chairperson of a committee may call an extraordinary meeting in consultation with the general manager.

Reports of Committees

- (a) If in a report of a committee distinct recommendations are made, the decision of council may be made separately on each recommendation.
- (b) The recommendations of a committee are, so far as adopted by council, resolutions of council. *(Clause 269 of the Regulation)*
