The successful candidate will assist the Fire Commander with managing both services, contributing to a model that is not commonly found in the industry.

This role is based at Norfolk Island; all qualified applicants are encouraged to apply.

Reporting to the Fire Team Leader, the Fire Officer 2IC plays a pivotal role in the operational and administrative management of both the Norfolk Island ARFFS and the Community Fire Service. You'll ensure compliance with all regulatory standards, lead training and development activities, and support the strategic direction of the fire services team.

This position requires a strong leadership presence and a commitment to excellence in emergency response and community safety.
